

By enrolling on the Leaders Program, participants agree to:

- Attend all program days, in sequence, at the one chosen location
- Provide a minimum of 30 working days' notice, prior to the program commencing, if the participant needs to defer their program. CEW will endeavour to move the enrolment to the next available program where 30 working days' notice has been provided by the participant or their employer
- Below are charges that will be incurred where less than 30 working days' notice is provided to withdraw or defer the Leaders Program:

- If a Participant is unable to attend the program, another suitable employee, from the same organisation can attend in their place. There is no charge for replacement of participants
- Program deferrals can only be arranged within the same financial year. Where a participant cannot attend another program within the same financial year and has requested to defer with less than 30 working days' notice, the above fees will be incurred
- If a participant commences a program and is subsequently unable to attend one or more days, the participant will forfeit that day/s. Replacement participants can only be arranged for full programs, no replacements can be arranged for specific day/s.

# Terms & Conditions

#### Privacy:

By enrolling in the CEW Leaders Program, the participant acknowledges that they have read and understood the <u>CEW Privacy Policy</u>

#### **CEW Events Attendance Policy:**

CEW requires all guests at 'in person' events to be fully vaccinated against COVID-19. 'Fully vaccinated' means the definition in place by the relevant State or Federal government at the time of the event. If a vaccination exemption applies, the Participant must complete a negative rapid antigen or PCR test on the day of the event before attending.

## Photograph, Video & Social Media Consent:

Photographs and videos may be taken throughout the Leaders Program for use on CEW social channels and/or marketing material. By attending the Leaders Program sessions, participants grant CEW permission to take photos and videos of them throughout the program and utilise these photos and videos in CEW materials and on social channels. Participants may request to opt out of photography, filming, or recordings by notifying our Leaders Program Team.

#### **Enrolment Changes by CEW:**

If circumstances occur where CEW must cancel a Program due to unforeseen circumstances, the payor will be offered a refund or the option to defer the participant to another Program. CEW will not be responsible for any airfare, hotel or any other direct or indirect costs or losses incurred by participants in any circumstances. You are strongly encouraged to take this into account if booking travel arrangements.

Where the Program mode of delivery must change from an in-person event to online or hybrid event at CEW's discretion, the cancellation policy applies. i.e., if you request to defer Programs due to delivery method being changed, cancellation fees will apply within 30 working days of the Program commencing. This includes circumstances where the changes are implemented by CEW within 30 working days.

#### **Definitions**

For the purposes of the CEW Terms & Condition, the following terms have the specified meanings:

**Defer** is defined as the request to change from one program to another if a Participant is unable to attend any of the seven days of the Program.

Withdrawal is defined as a Participant no longer being able to take part in any CEW Leaders Program.

Working Day is defined a business day, this excludes weekends and public holidays.

In person is defined as an event that takes place in a physical venue.

Online is defined as an event takes place via an online delivery.

Hybrid is defined as an event that is offered for both Face to Face and Online attendance.

**Suitable Employee** is defined as an employee in an established leadership role and deemed appropriate by the payor.
